#### General Service, Small Commercial

Manufactured Gas Plant Cost Recovery Factor .....	\$0.0556	per therm
Gross Receipts Tax Index (July 2022 - June 2023) .....	\$0.0281	per therm

#### General Service

#### Large Volume Service (minimum non-fuel bill 30,000 th/month)

Customer Charge .....	\$400.00	per month
Non-Fuel Energy Charge (includes \$0.06906/therm of fuel) .....	\$0.2712	per therm
Manufactured Gas Plant Cost Recovery Factor .....	\$0.0556	per therm
Gross Receipts Tax Index (July 2022 - June 2023) .....	\$0.0134	per therm
Purchased Gas Adjustment <sup>(1)</sup> .....	\$0.8000	per therm

#### Liquid Propane Service (LP)

Customer Charge .....	\$9.75	per month
Non-Fuel Energy Charge (includes \$0.15882/gallon of fuel) .....	\$0.72376	per gallon
Purchased Gas Adjustment <sup>(2)</sup> .....	\$1.8000	per gallon

- (1) Purchased Gas Adjustment ..... natural gas commodity subject to change monthly
- (2) Purchased Gas Adjustment ..... liquid propane gas commodity subject to change monthly
  - Surcharge ..... 10% of base rates and gross receipts (outside City of Gainesville)
  - Franchise Fee 1 ..... 6% of base rates (High Springs)
  - Franchise Fee 2 ..... 6% of base rates, PGA (Alachua)
  - City Utility Tax ..... 10% of base rates, gross receipts, surcharge, fran fee (incorporated areas)
  - County Utility Tax ..... 10% of base rates, gross receipts, surcharge (unincorporated areas)
  - Florida Sales Tax ..... 6% of all bill components except utility tax
  - Discretionary Sales Tax ..... Wild Spaces and School Board, 0.50% each, apply same as sales tax
