- (3) Under agreement, customers with demand less than 50 kW on-peak may be billed under this rate.
- (4) Under agreement, customers with demand less than 50 kW will be billed for a minimum of 35 kW under this rate.
- (5) Demand is the maximum amount of electric power measured over any 30-minute period during each billing month.
- (6) Demand of at least 400 kW; metered at primary voltage; and customer owned transformation and distribution facilities.
- (7) Service must be metered at primary voltage of 12 kV.

Surcharge	10% of base rates and gross receipts (outside City of Gainesville)
Franchise Fee	6% of base rates, gross receipts, surcharge (Alachua)
City Utility Tax	10% of base rates, gross receipts, surcharge, fran fee (Gainesville, Alachua)
County Utility Tax	10% of base rates, gross receipts, surcharge (unincorporated areas)
Florida Gross Receipts Tax Recovery	2.5641% of base rates, surcharge, franchise fee, fuel adjustment
Florida Sales Tax	6.95% of all bill components except utility tax
Discretionary Sales Taxes	Wild Spaces = 1.00% and School Board = 0.50%, apply same as sales tax
