Wood Resource Recovery, LLC (WRR) intends to negotiate with the Gainesville Renewable Energy Center, LLC (GREC) for the purpose of entering into an agreement to supply biomass material to the GREC facility near Gainesville Florida. This letter is a commitment to negotiate and does not constitute a binding contract; all terms and conditions will be mutually agreed upon prior to the execution of an agreement.

Proposed Term of Agreement: Delivery of Biomass material for a period of ten years after the initiation of commercial operation of GREC.

- 1. Material to Be Delivered: Biomass material meeting the following description and specifications:
 - a. Description: Biomass material derived from one or more of the following sources (Waste Biomass):
 - i. tree debris and clean, woody biomass material derived from urban land use activities, including residential landscaping, land clearing for urban land use, yard trimmings, tree service debris, and vegetative material from right-of way maintenance;
 - ii. clean, woody biomass material generated as a result of storms, fires, or other natural catastrophic events;
 - iii. clean, woody biomass material collected by public and private solid waste handling agencies (will not include any treated wood or construction and demolition material); and
 - iv. clean, woody waste derived from manufacturing, such as pallets, wood scraps, and other woody material, excluding any treated wood or construction and demolition material, that is accepted by, collected by, or disposed of by any public or private solid waste management company within the Waste Biomass Service Area.
 - v. For purposes of this Agreement, Waste Biomass shall not include any materials derived from forestry, agricultural, or forest products manufacturing operations.
 - b. Specifications:
- Waste Biomass shall not contain more than 1/10th of 1% by weight foreign material. Waste Biomass shall be no greater than 39% moisture content on a wet basis:

- ii. Material shall be sized so that at least 95% by weight will pass through a 2-1/2" round screen; no particles shall be greater than one foot in any
- iii. Material shall contain less than 4% ash on a dry basis.
- iv. Material shall be delivered on trailers suitable for unloading by the GREC unloading facility.

Volume:

- a. WRR shall deliver 300,000 green tons on a wet basis (183,000 bone dry tons per year, or 45,750 bone dry tons per calendar quarter).
- b. GREC and WRR shall agree upon the estimated volumes for each calendar
- c. The actual volume delivered may vary between 10,000 to 60,000 tons per calendar quarter, and annual total volume may be adjusted by plus or minus 10% on an annual basis at the discretion of GREC.
- Waste Biomass Service Area
- a. During the term of this agreement, GREC shall not accept Waste Biomass as described above from any other supplier or producer if such material was produced, derived from, collected within, or grown within the Waste Biomass Service Area. This area shall be defined as mutually agreed upon by WRR and GREC.
- 4. Remedies, Default
- a. In the event that WRR fails to provide Waste Biomass in sufficient volume, or does not meet the defined specifications, to meet its obligations under this agreement, GREC may obtain the amount of biomass equal to the shortfall from other sources, including those in the Waste Biomass Service Area. In this event GREC shall pay the amount required to procure such material, and WRR shall be liable for the difference between the contracted price and the actual price for the
 - b. WRR will post a performance bond to insure its performance of this contract equal to one (1) million dollars.
