

GRU 2017 “Echo Dot” eBill Giveaway Official Rules

The eBill Echo Dot 2017 Giveaway is sponsored by the City of Gainesville, d/b/a, Gainesville Regional Utilities (GRU). By voluntarily participating in the promotion, each entrant agrees to abide by these Official Rules, including all eligibility requirements, and understands that the results of the promotion, as determined by GRU and its agents, are final in all respects. This voluntary promotion is only open to current GRU customers who are 18 years of age or older at the time of entry. Employees or retirees of GRU, the City of Gainesville and each of their affiliates, subsidiaries, advertising and promotion agencies, and the immediate family members and/or those living in same household of such employees, are not eligible. No government, federal or state entities are eligible. GRU reserves the right to verify the eligibility of each entrant.

Eligible entrants who sign-up for eBill (www.gru.com/ebill) from March 17, 2017 to April 13, 2017, may be entered to win an Echo Dot.

Entrants must meet the following requirements in order to be entered into the promotion:

- **Sign up for eBill paperless billing**

Participants must sign up for eBill paperless billing between the dates of March 17, 2017 to April 13, 2017.

GRU is not responsible for computer problems or inadequate information provided in the entry. Redemption and use are governed by its terms and conditions.

4. RECIPIENT SELECTION

An entrant will be selected randomly and will be notified of selection by email. Recipient must be able to provide proof of being a current GRU customer in order to claim their prize. Forms of proof include, but are not limited to: GRU account number, verification of name and service address, and/or a copy of a recent utility bill.

5. REDEMPTION OF PRIZE

Recipient may choose to receive their prize by mail or in person at the Gainesville Regional Utilities Administration Building, 301 SE 4th Avenue, Gainesville, FL 32601. If redeeming their prize in person, recipients must provide their name and any other requested information at the security desk in the lobby. Mailed prizes will be sent to the address provided by the giveaway recipient.
